1. CONTAINER FEES:

General merchandise in cartons, or palletized/unitized cargo.

2. FACILITY FEE: (Applies to full container examinations only) (FCL)

A **\$75.00** fee will apply to full container examinations in addition to all other examination fees. This fee covers in and out interchanges, security, yard handling, equipment and cargo liability. This fee will not apply to less-than-container load (LCL) examinations.

5. FREE TIME AND STORAGE “AFTER RELEASE”:

FREE TIME: The day we advise the customs broker and trucker that a U.S. Customs or Government Exam is released, and the following day, are considered free time. Storage starts the day thereafter, or third day. If the last free day is Saturday, free time carries through to the following Monday. If the last free day is Friday, storage starts on Saturday.

STORAGE AFTER FREE TIME EXPIRES: (THIRD DAY):

- Full Container (FCL)
 - 20’ Container \$20.00 Per Day
 - 40’,45’,48’,53’ Containers..... \$30.00 Per Day
- Less than container (LCL)..... \$12.50 Per Day

6. STORAGE “ON HOLD”:

If we are required by Government Agency to “HOLD” the shipment in the original container or in our warehouse after examination, the following fees apply. These handling fees only apply if cargo must be moved from the examination staging area to hold area following 10 days on hold.

- Yard Storage (full container)(FCL)
 - 20’ Container.....\$20.00 Per Day
 - 40’,45’,48’,53’ Containers..... \$30.00 Per Day
- Less than container (LCL)..... \$12.50 Per Day

9. REFRIGERATED CONTAINER YARD SERVICES:

Fees for refrigerated containers will be billed in 24 hour increments starting at the date and time the container is received in our yard for examination.

10. DAMAGED OR HARD TO HANDLE EXAMINATION CARGO:

During the examination process, when we notice cargo damage or feel that further handling may cause damage, we will notify the broker or importer – allowing them or their representative to view and/or supervise the handling process. Importer personnel and equipment may be used to assist in handling and/or cartage of fragile or delicate cargo after the inspection process is completed.
